Notice inviting Expression of Interest (EOI) for Empanelment of Organizations under state component of PMKVY 2.0 Program for training in various sectors.

- 1) Himachal Pradesh Kaushal Vikas Nigam, Government of HP, Shimla (hereinafter called HPKVN) invites Expression of Interest for Empanelment of Organizations with relevant experience and good track record to undertake skill training programs based on National Skill Qualification Framework (NSQF) for PMKVY 2.0 Centrally Sponsored State Managed (CSSM) component.
- 2) In 2017, HPKVN had taken out an EOI to empanel TSP's to train youth of Himachal under 15 Sectors (attached as Annexure 2.0) in Category-1 & 4 in PMKVY. Now HPKVN intends to add new sectors in category 1 & 4 and also include Category 2& 3 (State specific) as per Annexure 1.0 for trainings in PMKVY 2.0.
- 3) Program quality and implementation will be monitored and evaluated by HPKVN, as per its Quality Standards and Procedures defined in State's Operations Manual for CSSM.
- 4) HPKVN reserves the right to shortlist any or all of the applicant (Organizations), or reject any or all applicants, without assigning any reason whatsoever. HPKVN reserves the right to postpone or cancel the procurement process at its sole discretion and without assigning any reason.
- 5) It is to clarify that 113 TSP's/Organization which are already empanelled via letter no **HPKVN/1(140-2017 -629-632** for Category 1 &4 with HPKVN need not to apply for any of the 15 Sectors previously allocated as per attached Annexure 2.0. However, if they wish to apply for new sectors (listed in Annexure 1.0) they can as a fresh bid for each sector.
- 6) Further allotment of Sectors to already empanelled TSP's for old EOI in 2017 shall be made through separate process of review of their performance based on the presentation / evaluation criteria to be determined by HPKVN. List of previous allocated sectors attached at Annexure 2.0
- 7) Training Service provider/ Organization can apply only for **maximum 5 sectors** by attaching separate Form IV for each sector of the Bid Response Format (This applies for TSP's applying for the first Time)
- 8) Interested Organizations may submit their EOIs to the undersigned on or before 10th September, 2018 by 1600 hrs. through post along with a Demand Draft of Rs. 10,000/- (Ten Thousand Only) in favor of **"Managing Director, Himachal Pradesh Kaushal Vikas Nigam"** payable at Shimla as non-refundable processing fee. Late submission will not be entertained and will be returned unopened.

Background

Himachal Pradesh Kaushal Vikas Nigam (HPKVN)

The Himachal Kaushal Vikas Nigam (HPKVN) was established on 14th September 2015 as a skill development harmonizer under Department of Planning to design and implement the Skill Development Policy in the state of H.P. The HPKVN has been mandated to implement the External Aided Skill Development Project, which aims at strengthening the HPKVN capacity to deliver the quality training and modernize and reform HP's TVET institutional framework, scale up the State's annual TVET training capacity and make the trainees employable in the domestic industry as per their needs. The Department of Technical Education of Himachal Pradesh is the Executive Agency for Skill Development Mission. HPKVN is Nodal Agency for implementing the Skill Development Project. HPKVN has also been mandated to implement the ADB funded skill development project. HPKVN, Department of Higher Education, Department of Technical and Vocational Training and HP Public Works Department are the implementing agencies for this project. Rural Development Department, Urban Development Department, Department of Labour & Employment, and Department of Economic & Statistics are the line departments for this project. HPKVN is mandated to act as harmonizer for this programme and converge all activities of skill development being carried out by various implementing agencies and line departments of the State. HPKVN is also mandated to implement the state component of the Pradhan Mantri Kaushal Vikas Yojna (PMKVY) 2.

Pradhan Mantri Kaushal Vikas Yojana (PMKVY)

Pradhan Mantri Kaushal Vikas Yojana (2016 - 2020) hereafter referred to as PMKVY is the flagship outcome-based Skill Training Scheme of the Ministry of Skill Development and Entrepreneurship (MSDE), Govt. of India. The Union Cabinet has approved the Scheme for four years (2016 – 2020) to impart skilling to 10 million youth of the country.

The skill training under the PMKVY scheme will be imparted under the following categories–

Category- 1: Includes all the NSQF aligned job roles developed by Sector Skill Councils (SSC's).

Category-2: State specific non SSC listed Job roles which are NSQF aligned

Category-3: Job roles related to traditional arts and crafts targets (Traditional Apprenticeship)

Category -4: Job Roles with Significant demand in the state.

2. Goal/Objective of Eoi:

The Objective of the Eoi is to empanel Firms / TSPs with relevant experience and good track record to undertake skill training programs based on National Skill Qualification Framework (NSQF) to train youths of the state and make them employable and capable of earning their livelihoods in the identified category.

In 2017, HPKVN had taken out an EOI to empanel TSP's to train youth of Himachal under 15 Sectors (attached as Annexure 2.0) in Category-1 & 4 in PMKVY. Now HPKVN intends to expand these sectors and also include category 3 (State specific) as per Annexure 1.0 for trainings in PMKVY 2.0.

1. Scope of Work/Terms of Reference:

1. TSP/Firm selected /empanelled through this process may be allocated training targets under identified sector under Category 2 & 3 of PMKVY 2.0 detailed as under:

2. TSP/Firm will work closely with HPKVN in developing Qualification Packs (QPs)/ National Occupational Standard (NOS) for Category 2 & 3 of PMKVY 2.0 only, and getting these approved by SSC/NSDC.

2. Instruction to Bidders

Interested applicant may furnish their EOI through post by giving all the necessary documents in English as specified in formats provided in the EOI under Bid Submission Formats.

- HPKVN reserves the right to withdraw this EOI, without assigning any reasons for the same, if HPKVN determines that such action is in the best interest of the Government of HP. HPKVN undertakes that all the information shared by the applicant will be held in strict confidence and will not be made public unless directed by law.
- The response submitted to this EOI and all correspondence shall be in English and shall confirm to the forms attached. Any interlineations, erasures or over writings shall be valid only if they are initialed by the authorized person signing the EOI.
- The EOI submitted should be concise and contain only relevant information as required under this document. The applicant submitting the EOI would be responsible for all its expenses, costs and risks incurred towards preparation and submission of the EOI. HPKVN shall, in no case, be responsible or liable for any such costs whatsoever, regardless of the outcome of the process.
- The EOI submitted by the applicant shall remain valid for a period of 180 days after the closing date for submission of EOI prescribed in this document. EOI validity expressed for a period less than 180 days shall be rejected.
- At any time prior to deadline for submission of EOIs HPKVN may modify the EOI document. The amended document shall be notified through website and such amendments shall be binding on the Bidders.
- Bidders are advised to study all instructions, forms, requirements and other information in the EOI documents carefully. Submission of proposal shall be deemed to have been done after careful study and examination of the EOI Document with full understanding of its implications.
- The firms/TSPs can form joint venture/Associations. All such Joint venture/Associations should be supported with valid documents
- The response to this EOI should be full and complete in all respects. Failure to furnish all information required by EOI documents or submission of EOI not substantially responsive to this document will be at bidder's risk and may result in rejection of its submission.
- The bidders are responsible for all costs incurred in connection with the participation in this process, including, but not limited to, cost incurred in conduct of informative and other diligence activities, participation in meetings/ discussion/ presentations, preparation of EOI documents, in providing any additional information required by HPKVN to facilitate evaluation process.
- The Training Service Providers/Firms shall be paid as per common cost norms notified by MSDE, Govt. of India from time to time based on actual performance.
- HPKVN in no case will be responsible or liable for those costs, regardless of conduct or outcome of the process.
- The bidder shall furnish processing fee of Rs. 10,000 in the shape of bank draft with the

EOI. EOI not supported with processing fee shall be rejected.

- This EOI does not commit HPKVN to award a contract or to engage in negotiation.
- The bidder shall have to score minimum 60 % Marks to be qualified for the empanelment.
- TSP's applying for category 3 (Handicraft) will have to prepare the Himachal Specific QP's/NOS and get it approved from relevant SSC at no additional cost.
- EOI documents submitted by Firms/Associations will be reviewed by an expert panel constituted for technical evaluation purpose by HPKVN.
- All material submitted by bidder will become the property of HPKVN and may be returned completely at its sole discretion.
- HPKVN may at its sole discretion and at any time during the evaluation of EOI, disqualify any applicant, if the applicant has made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements;
 - A record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion, financial failures etc. in any of the projects in the preceding three years.
 - Submitted an EOI that is not accompanied by required documentation.
 - Use of modified formats for submission.
 - Failed to provide timely clarification related thereto, when sought.
 - Been declared ineligible/blacklisted by State/UT/Central Government or any Public Sector Undertaking under them.
 - Been in litigation with any Government agencies/institutions in India
 - Made an attempt to influence the Bid evaluation
 - Processing fee as Demand Draft for Rs. 10,000 not attached with the proposal.
